

1. PROLOGUE

The purpose of this Data Processing Information document is to allow for Szatmári Transport Kft. (seat: Vasvári Pál street 5-7, 2347 Bugyi, Hungary; company registration number: 13-09-081709) to inform you of its data processing measures, **in compliance with the provisions of Regulation 2016/679 of the European Parliament and Council (27 April 2016) on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation, GDPR) and the applicable Hungarian legal regulations.**

Szatmári Transport Kft. is considered as a data processor (hereinafter: Data Processor) with regard to its data processing explained herein. The Data Processor can be contacted via e-mail at: adatvedelem@szatmaritransport.hu

Throughout its data processing procedures, the Data Processor shall comply with the provisions of the applicable legal regulations and it shall fully respect the protection of the basic rights and of the privacy of private individuals when establishing its data processing procedures, with special attention to the provisions of the General Data Protection Regulation.

2. THE PURPOSE OF DATA PROCESSING

The purpose of data processing is to handle the requests for price quotations received by the Data Processor and replying to these in accordance with the services requested by you.

3. THE SCOPE OF THE PROCESSED DATA

The Data Processor shall register your name, e-mail address, telephone number.

4. THE SOURCE OF THE DATA

Your data may reach the Data Processor either through the <https://www.szatmaritransport.hu/ajanlatkeres> web page, or via e-mail or post.

5. ACCESS TO THE DATA, STORAGE

The Data are used outside our Commerce Department only by those co-workers of the Data Processor who are involved with the provision of the price quotation in question.

The Data Processor stores the Data in its own electronic systems.

6. THE DURATION OF DATA PROCESSING

The Data Processor stores the data for 5 years after their receipt. If a contractual relationship is created between our companies then Szatmári Transport Kft. shall store the personal data for 7 years following the contractual connection between the two companies.

7. THE LEGAL BASIS OF DATA PROCESSING

Data processing by the Data Processor is based on your consent if you contacted us via the <https://www.szatmaritransport.hu/ajanlatkeres> website and provided your consent, or if your data reached the Data Processor as a result of your own initiative.

8. THE RIGHTS YOU ARE ENTITLED TO

Please be informed that you may exercise your rights on the basis of legal regulation at the adatvedelem@szatmaritransport.hu email address, on the basis of which – within the framework set forth by the law:

- a) you may request access to the personal data processed with regard to you and to the copies thereof; (Article 15)
- b) you may request information regarding the main characteristics of the data processing (purpose, scope, data processors involved, duration); (Article 15)
- c) you may withdraw your consent at any time; (Article 7 (3))
- d) you may request that any inaccurate personal data concerning you be rectified without undue delay or that incomplete personal data be completed; (Article 16)
- e) you may request that the personal data concerning you be deleted without undue delay (Article 17)
- f) you may request that the use of the data be restricted (Article 18)
- g) you may request to receive the data concerning you and provided by you in a widely used, machine readable format, or you may request that we forward such data directly to another data processor (Article 20);
- h) you may initiate a procedure at the supervisory authority competent at your place of residence, at your workplace or at the place where the violation of rights is claimed to have taken place (Article 77).

This supervisory authority in Hungary is the National Authority for Data Protection and the Freedom of Information (Budapest, H-1125, Szilágyi Erzsébet fasor 22/c.).

In the case of any violation of rights, you may file a lawsuit against the data controller or the data processor with the court of the member state of the place of business of the data controller or the data processor and with the court competent at your place of residence.
